It was discussed and decided to remove the By-Laws from the Website until the new version could be installed.

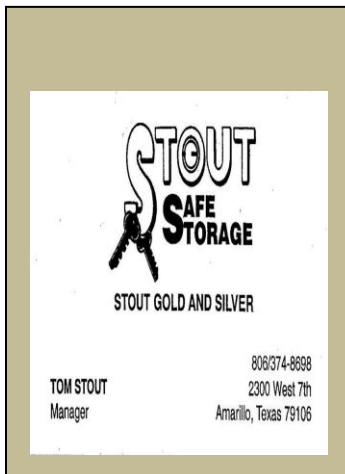

The August meeting was an Ice Cream Social and seeded hunt at Austin Park. We had 21 hunters look for the 23 coins hidden there. At this time there are 2 mercury dimes, 2 IH pennies and 6 buffalo nickels that were planted and still unaccounted for. So go get them! The seeded targets will not need to be dug as all will be near the surface. They haven't watered much there so lets be careful on our digging. Thanks for the Ice Cream and cookies and brownies! Yum!

The August Club Outing was down at Sandy Beach on Lake Greenbelt (east side of lake) Saturday and Sunday August 20th and 21st. We had 18 hunters get sand in their shoes and lots of clad was found but not much else this round. A 52D penny was found on the beach as well as a 45S penny at the park later after lunch. Thanks for those that went and it turned out to be a very pleasant hunt that morning since the moderate temperatures and slight breeze made it nice.

September is a seeded hunt with a twist. You can't use your own detector you have to switch with someone and use a different model or brand. John thought this up and I like it. We will meet at Austin Park at 6:00PM Thursday the 15th and do the switching of detectors and training for about 15-20 minutes then off to the races on locating the seeded coins (in addition to ones already planted from before).

October will be a rematch at the Girl Scout camp. We will hunt Saturday and Sunday the weekend of Oct. 15th and 16th. Let's meet at 9AM at the camp.

Again let me add a reminder about getting permission before hunting private property and watch your digging in the turf. If you hunt a park look for the areas they have watered. There is no such thing as a plug with the ground this dry. Have fun, be safe and see you next month.

TEXAS TREASURE HUNTING

GEMS

Some of the best agate, jasper, chert and petrified wood found in the nation comes from Texas. Blue banded, moss and red and black plume agates are found near Alpine in Brewster County. Similar agates are found in Jeff Davis, Hidalgo, Hudspeth, Presidio, Reeves, San Patricio and Starr Counties. Petrified wood can be found in Amarillo, Bastrop, Brazo, Comal, Duval, Fayette, Gonzales, Lavaca and Uvalde Counties. With fine quality palm wood coming from Live Oak and Webb Counties. Good quality chert can be found in limestone formations in McCulloch, Moore and San Saba Counties. The material from Moore County also is called Alibates flint and was used by prehistoric and modern day Indians to make weapons and tools. The quarry from which the Indians obtained their flint is now Alibates State Park.

RELICS COINS AND JEWELRY

Texas has a rich history of early settlements and battlefields. The perfect combination for an energetic relic hunter. Here are a few ideas to get you started.

Schools and College Campuses Parks / Playgrounds / Picnic Areas. Foundations, Wells and cellar holes of old Churches or houses, downtown construction sites. Swimming holes, Beaches and Natural springs camp grounds, Boy Scout Camps, WPA camps, and mining camps, Sports facilities, Ghost town Rodeo Arenas, Riding Stables and Race Tracks, Old Fair grounds, Carnival Locations and Old town dump sites.

LOST TREASURES

As in other areas of the US, there are several tales of lost treasure in Texas concerning caches buried for safety. In many of these stories, people either died or forgot where they buried the stash. Contributing factors include:

1. Federal laws making possession of gold illegal in the early 1900s
2. Distrust of banks during the great depression.

Gold bars were lost in Paisano Pass near the Brewster-Presidio County line. In Brewster County notorious Texas outlaw Sam Bass spent time in the 1870s robbing stagecoaches including several near Deadwood in the Dakota Territory. Seeking other opportunities, Bass and his sidekick Joel Collins went to Big Springs, Nebraska. And there held up the Union Pacific Railroad, escaping with a payroll of 3,000 freshly minted 1877 \$20 gold coins in a trunk. Although \$25,000 worth of coins (1250 gold coins) were recovered. There are still about 1750 coins not accounted for. Collins and Bass died without revealing where the rest of the loot was. It is said that Bass had hidden his part in Cove Hollow about 30 miles from Denton, Texas. Who knows, it may still be there today. It is thought a lost cache of \$20 gold coins may be in Palo Duro Canyon, Armstrong County.

Colorado Group Hunt

July 23, 2011 fourteen members of the AT&THA went to a mountain camp near Fairplay, Co.

A few people went earlier and scouted the area. By Saturday everyone had arrived at the campground.

Sunday and Monday members went to a Claim owned by Chad. Chad's claim was about six miles north of Alma, Co. Chad charged \$10.00 per day per member for the privilege to pan for Gold on his claim. Chad had dug a fifteen foot deep hole to bedrock with a backhoe. Two members made a deal with Chad and opened a waterway to the dug out hole. The hole was dug by a back-hoe and Chad wanted a river entrance to the hole. While digging the waterway Chad allowed us to work with his dredge. It took two days to dig the entrance. Chad gave the two all the concentrates from the digging. The gold in the concentrates to this day is not known. Mean-while the rest of the members ran about two yards of material through two high-bankers piled up from the dugout hole. The concentrates from the material have not been cleaned. I'm not sure when the Club will clean the material.

Tuesday, seven or eight members went to Cache Creek, a claim operated by GPOC. Members must have a GPOC to work this claim. Some Gold was found by members on this claim. This was a very good looking Claim and hopefully we can return there in the future.

Other members went to a Claim owned by Chad at Beaver Creek. No one has reported to me if any Gold was found there.

One member went to a local fishing hole and tried out his luck in a creek. He told me he did not have much luck with the fish. Actually the fish were the lucky ones.

Mark and Skip did most of the cooking, by the way they are very good cooks. A cook tent was set up for cooking. A campfire was burning most of the time. It would burn out by morning, but usually was hot enough to restart kindling in the morning. A camp guard was on duty each day while the others were out having fun.

I had to leave Tuesday night because of a doctor's appointment Wednesday. So what happens the rest of the week will have to be written by someone else.

One of the most memorable areas that I've hunted was an old [drive-in movie theater](#). I was stationed at Redstone Arsenal, (Huntsville) Alabama at the time. The theater was located on Highway 231 South (Memorial Parkway). Under the screen was a trailer where the groundskeeper lived. One day while he was out front mowing the lawn I stopped by and inquired about hunting the playground area in front of the screen. During the conversation I learned that the drive-in was built in 1949 and had been detected by other hunters. However, business was slow and the drive-in was now in the process of closing down for good. Permission was granted to metal detect so I parked inside and concentrated on the playground located directly in front of the screen.

The playground was approximately 150 feet wide and about 30 feet deep. In the front were two chair swings on either side of a cement pad (use unknown). In front of the cement pad was a see-saw and beyond that a merry-go-round. On the left was another merry-go-round and a swing set. On the right was another swing set and in the middle toward the back was a slide playhouse. All of the equipment looked its age. It is hard to remember exactly where I found all of the coins. I kept accurate records of the drive-in and to this day only remember digging up one of the coins...a Ben Franklin half dollar. I only hunted in the playground as most of the area where the patrons would park and watch the movies was paved over. I was using a White's 5000-D metal detector at the time (I still have it).

The date was March 3, 1980. I found 2 silver Washington quarters, 1 [Standing Liberty quarter](#) (1929-S), 3 Mercury dimes, 4 silver Roosevelt dimes, 30 wheat pennies, 46 new pennies, 7 clad dimes, 4 nickels, 4 quarters, and 1 silver ring. It was a good day of detecting and I had the entire area to myself. I made plans to return the following week.

On March 8, 1980 I detected the playground again. Coins were popping out of the ground like the previous hunt. That day I found 1 silver Washington quarter, 3 Mercury dimes, 2 silver Roosevelt dimes, 18 wheat pennies (one was a 1909), 8 clad dimes, 1 nickel, 25 new pennies and another silver ring. The drive-in was starting to become a very productive site.

On March 10, 1980 I hit the playground again but coins were starting to thin out somewhat. I managed to pull up 1 silver Washington quarter, 1 Mercury dime, 1 silver Roosevelt dime, 5 wheat pennies, 1 clad dime and 5 new pennies. All in all it was still a good day. Could there still be more coins hiding in the playground?

I found out the answer on March 11, 1980. Yes! Coins were still sparse but I did find 2 more Mercury dimes, 2 silver Roosevelt dimes, 6 wheat pennies, 2 clad dimes, 2 nickels, and 12 pennies. Looks like things were closing down in the coin department too.

I had to pull a short tour of duty at Fort Hood, Texas. At the time I was a Meteorological Observer in research and development. It was a great job and I really enjoyed that type of work. When the tour was up I went on a 30 day leave (vacation) back to Pennsylvania. I guess I'm trying to say it was a few months before I got to go back to the drive-in. Surely, there had to be more coins.

A big change occurred while I was gone. The screen burned down some time during May of 1980. All of the playground equipment was now gone and the lot had been bulldozed over. On August 10, 1980 I hit the vacant playground again. The one coin I remember finding after 19 years is the Ben Franklin half dollar I found under the see-saw. After hitting the area 4 times, I still missed a rather large coin. That is why it pays off to hit an area time and time again. When the day was done I ended up with the 1954 B.F. half dollar, 2 Mercury dimes, 3 silver Roosevelt dimes, 1 silver war nickel, 6 wheat pennies, 1 clad dime and 5 new pennies.

September 7, 1980 would be my last visit to Whitesburg drive-in. It was a sad feeling knowing that the end of an era was coming to a close. The movies had not played for some time now and the screen and playground were gone. No more children to laugh and play on the swing sets. No more parents watching the children and discussing current events. All gone, just memories now. I ended the day with 2 Mercury dimes, 2 silver Roosevelt's, 8 wheat pennies, 2 clad dimes and 7 new pennies. Whitesburg drive-in was undoubtedly a great place to metal detect. I found a total of 239 coins with a face value of \$9.68. \$4.50 of that was in silver. Recent correspondence with metal detecting buddy Robert Hoard in Huntsville tells me that the entire place is now Whitesburg Shopping Center. Bob Hope said it the best, "thanks for the memories."
